



SmartMobile Daily Competition Terms and Conditions

1. This prize draw is organized and promoted by iSmart (Pty) Ltd, Registered office: 40 Somerset Road, Greenpoint, Cape Town, South Africa.
2. The prize draw is open to all SmartMobile subscribers, who are using their SmartMobile SIM card.
3. However, if you are an employee of iSmart (or its parent, subsidiaries or any affiliated company) or are otherwise associated with the prize draw, you and any member of your family or any agent are not eligible to enter.
4. By entering the prize draw, you are deemed to have read and accepted these terms and conditions. All entry instructions form part of these terms and conditions.
